

STATE LEVEL BANKERS' COMMITTEE, GOA
Minutes of meeting of steering sub group of SLBC, Goa
on Priority Sector lending held on 12.05.2016 at Panaji, Goa

1. The meeting of the Steering Sub Group of SLBC Goa on Priority Sector lending was held under the Chairmanship of Shri Braulio Fernandes, General Manager, Goa State Cooperative Bank Ltd, at State Bank Learning Center, Patto, Panaji Goa on 12.05.2016 at 10.15 a.m. Shri V.D.Vakil, Asstt General Manager, Reserve Bank of India, Panaji, Shri Vedpathak, AGM NABARD and Shri. K.S.Anabalgan Dy. General Manager (Agri), State Bank of India, Mumbai LHO & Member Secretary, SLBC Goa were also present for the meeting. The list of participants is enclosed.
2. At the outset Shri Shashank Shahane, Chief Manager (F.I.), State Bank of India, Zonal Office Panaji welcomed the participants. Shri K.S.Anabalgan suggested that the status of the steering subgroup meetings should not be diluted and the senior level officers, as decided in the original set up of the steering sub group in February, 2009, be adhered to. He further opined that a communication be sent to those who were not present in the meeting.
3. The minutes of meeting held on 11.02.2016 were circulated among the members and as there were no suggestion/amendments, the same were treated as read confirmed. The present position of the action taken on the action points emerged in previous meeting is as under:

4. Review of the Banks' performance under Annual Credit Plan 2015-16 as on 31.03.2016 was taken. Shri Anbalagan informed that List of top 5 banks in achievement of ACP be prepared so also the list of five banks with low performance and it should be presented in the SLBC meeting. He further informed that the SLBC data should be reported in Crores. Calendar of BLBC and DCC/DLRC meetings be advised to all concerned Govt. Departments also so as to enable them to depute suitable officers for the meetings. He further advised Lead District Managers to hold at least 3 meetings (Krishi Melas) in a quarter. Officials from Agriculture department, Animal Husbandry Department and Fisheries department should also be invited to participate in the mela.
5. Shri Vedpathak informed that the Bankers may contact the Farmers' Clubs from the list provided.
6. The Lead District Managers informed that the presence of BDOs in the BLBC meeting is essential but the response from BDOs was not satisfactory. Shri Anbalagan advised them to take up the matter with the Director, Panchayat/Distt. Collector.
7. The Lead District Manager (South Goa) informed that he has taken up matter with the Director Agriculture for sharing the Krishi Card data. He also advised that he will be discussing with the Director Agriculture for giving access to Banks with a login ID to each bank.
8. Shri Vakli suggested that minutes of BLBC meeting be sent to all concerned.


