Minutes of meeting of steering sub group of SLBC, Goa
on Govt. Sponsored Schemes held on 12.05.2016 at Panaji, Goa

1. The meeting of the Steering Sub Group of SLBC Goa on Govt. Sponsored Scheme was held under the Chairmanship of Shri K.S.Anabalgan, Dy. General Manager (Agri) State Bank of India, Mumbai LHO & Member Secretary, SLBC Goa at State Bank Learning Center, Patto, Panaji Goa on 12.05.2016 at 12.15 noon. Shri Sandeep Sopori Asstt. General Manager State Bank of India, Mumbai LHO was also present for the meeting. The list of participants is enclosed.


