Subject: Issuance of Acknowledgement Receipt under Pradhan Mantri Fasal Bima Yojana - regarding.

Sir/Madam,


1. As you may be aware that Pradhan Mantri Fasal Bima Yojana [PMFBY] has been approved by the Union Cabinet on 13th January, 2016 to ease the burden of premium of crop insurance on loanee and non-loanee farmers for their cultivation. This scheme will have a very low premium for the farmers on the principal sum insured. More details of the scheme may please be seen at this Department's website i.e. <http://agri-insurance.gov.in/PMFBY.aspx>.

2. To provide farmers with some minimum documentation regarding their crop insurance, it was recently decided to provide them with an Acknowledgement Receipt with synopsis of their policy alongwith a pocket size folio for ease of carrying. Regarding operationalization of this measure, on the approval of insurance of individual farmers by the respective insurance company on the basis of farmers-wise declarations received from the concerned Bank branches, an Acknowledgement Receipt shall be electronically transmitted by the insurance companies to the concerned Bank Branch which shall issue printout of the same to the farmer alongwith the folio.

3. Accordingly, SLBC & NABARD are requested to arrange for printing and onwards distribution of folios to the branches/RR. These folios shall be printed by the SLBC conveners for Commercial Banks and NABARD for Cooperative banks and RRBs and kept ready for issue to farmer at the branch level.

4. Minutes of the meeting held in this Department with SLBC, NABARD and IBA in this regard on 14.12.2016 alongwith sample of Pocket Size Folio and Acknowledgement Receipt are enclosed herewith for compliance.

This document is only a farmer's premium acknowledgement; Coverage under crop Insurance will be subject to scrutiny of necessary documents and applicability of relevant provisions as per the operational Guidelines of respective schemes.

Minutes of the Meeting to discuss preparations for folio/acknowledgement receipt held on 14.12.2016 at 2.30 PM in Committee Room No. 138, Krishi Bhawan, New Delhi under the chairmanship of Dr. Ashish Kumar Bhutani, Joint Secretary in this Department.

A meeting was held on 14th December, 2016 under the chairmanship of Dr. Ashish Kumar Bhutani, Joint Secretary, (C&C), Department of Agriculture, Cooperation and Farmers Welfare with representatives of SLBCs, IBA and NABARD. List of participants is annexed.

2. It has been decided to provide **acknowledgement receipt** on PMFBY/WBCIS to all insured farmers (both loanee and non-loanee) which can also be used as evidence of having insured their crops and to serve as a policy document. Alongwith the receipt a **Folio** will also be provided to the insured farmers and will have all basic information about the scheme.
3. The chairman informed that the size/design/content of the folio (pocket size) and logo along with tagline and acknowledgement receipt has already been approved by competent authority. Regarding printing of folios, it has been decided that the concerned convenor banks of SLBCs will print requisite number of folios based on the requirement of member banks and the cost of the same will be shared by the concerned member banks from the administrative charges being provided under the scheme. For Cooperative Banks and RRBs, NABARD will undertake the task and the cost will be born from the Financial Inclusion (FI) fund. NABARD has also been asked to take up the matter in the Advisory Committee of FI fund for their approval and inform this department accordingly.
4. Regarding acknowledgement receipt concerned insurance companies will provide electronic copies to the concerned branches of commercial banks and hard copies to the branches of Cooperatives and RRBs after acceptance of proposal submitted by financial institutions and other intermediaries.
5. For the time being the folios have been designed only in English and Hindi and translation in other regional languages will be undertaken by the SLBCs/NABARD in consultation with the concerned state department.
6. It was decided that DAC & FW will immediately provide the electronic copy of the folios and acknowledgement receipt to the SLBC/NABARD to take further necessary action in terms of translation, printing and distribution to concerned member branches on top priority basis so that the same may be distributed to farmers from Rabi 2017-18 itself.
7. The meeting ended with vote of thanks to the chair.
