Dear Chief Secretary,

You are aware that this Department is implementing Dairy Entrepreneurship Development Scheme (DEDS) through NABARD and Nationalize Banks, which has received overwhelming response from dairy entrepreneurs across the country. DEDS is the only direct beneficiary oriented scheme covering loaning in the entire value chain from cattle procurement to sale of milk through outlets. Since its inception in September, 2010, the scheme has benefited about 2.70 lakh farmers with capital subsidy of Rs.1059 crore upto 30.04.2017.

2. State Level Bankers Committee (SLBC) is the main institutional forum for review of programme and policies by all the financial institutions. SLBCs should therefore cover monitoring of bank funded dairy development scheme DEDS, wherein Nationalized, Commercial and RRBs provide loan assistance.

3. While reviewing the progress of the scheme, the Department has observed that inspite of the provision for regular review of scheme by SLBC in the operational guidelines, the scheme was not considered for review by SLBCs.

4. I would, therefore request your kind intervention and direction to concerned officers including convener of SLBC to include DEDS as an agenda for review of implementation in SLBC meeting. A copy of administrative approval for 2017-18 is enclosed for ready reference.
