1. BC Registry – Launch of Portal

The BC Registry seeks to provide a Centralized Repository of relevant information on BCs and also a robust MIS, thus facilitating monitoring and oversight of the BC network. In this connection, on the basis of the Framework provided by RBI and in consultation with stakeholders, IBA has developed the BC Registry Portal (<u>www.bcregistry.in</u>) which has since gone "live" wherein banks shall upload data pertaining to the BCs deployed by them. You may please ensure that the timelines, as mentioned in the captioned circular are strictly adhered to and the data uploaded in correct and complete in all respect, so that the Portal is fully operational in a time bound manner.
